Please remember to keep the speed of any vehicle under 25 MPH. A speed limit sign is posted on Broad Hollow at the entrance, but the limit applies throughout the development.



# **Spring Maintenance**

Weed control is always an ongoing challenge. SCVHOA contracts to have the weeds along the sides of the road, fire hydrants, and pump houses sprayed. The spraying is done soon after the weeds sprout in late May. Each lot owner is responsible to keep their property clear of noxious weeds; such as Dyer's Woad and white top. RV lots must be vacated by 10/31 each year.

# **Waterfront Access**

Swan Creek Village property owners have the privilege to purchase shares or rent an access key to beachfront property. A gate key may be rented yearly for \$50, or shares in the L.L. Cook Waterfront Perpetual Park Corporation Waterfront Users Association may be purchased. The property starts at the north end of the Trapper Council Boy Scout camp and is 80 feet wide along the shoreline. Purchase of shares provides additional access along the high water mark.
